RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**"), dated as of October 4, 2017, is made by Wilmington Trust, National Association, as the Note Collateral Agent (as defined below), in favor of each of HD Supply Facilities Maintenance, Ltd., a Florida limited partnership, HDS IP Holding, LLC, a Nevada limited liability company, HSI IP, Inc., a Delaware corporation, HD Supply Support Services, Inc., a Delaware corporation, and White Cap Construction Supply, Inc., a Delaware corporation (each, a "**Grantor**", and collectively, the "**Grantors**").

A. Reference is made to the Indenture, dated as of December 4, 2014 (the "**Original Indenture**"), as amended and supplemented by the First Supplemental Indenture, dated as of December 4, 2014 (the "**Supplemental Indenture**" and, together with the Original Indenture, the "**Indenture**"), in each case, among HD Supply, Inc. (the "**Company**"), the subsidiary guarantors party thereto and Wilmington Trust, National Association, as trustee and note collateral agent (the "**Note Collateral Agent**"). Capitalized terms not otherwise defined herein shall have the meanings set forth in the Indenture.

B. Reference is made to (i) the Collateral Agreement, dated as of December 4, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "**Collateral Agreement**"), among the Company, the Grantors, the other grantors named therein and the Note Collateral Agent, and (ii) the First Lien Secured Note Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of December 4, 2014 and recorded with the U.S. Patent and Trademark Office on December 5, 2014 at Reel/Frame 5414/0512 (as amended, restated, supplemented or otherwise modified from time to time, the "**Grant Agreement**"), among the Company, the Grantors and the Note Collateral Agent, pursuant to which, among other things, the Grantors granted, in the case of the Collateral Agreement, and confirmed, in the case of the Grant Agreement, a security interest to the Note Collateral Agent, for the benefit of the Secured Parties, in, among other things, all Trademarks (as defined in the Collateral Agreement) of such Grantors, including, without limitation, those items listed on Schedule 1 hereto under each of such Grantor's name (collectively, the "**Trademarks**").

C. In connection with the satisfaction and discharge of the Indenture and the termination of the Collateral Agreement and the Grant Agreement, the Grantors have informed the Note Collateral Agent of their desire to obtain the release of all right, title and interest of the Note Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks, including those granted under the Collateral Agreement and confirmed by the Grant Agreement.

D. Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Note Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks, including those granted pursuant to the Collateral Agreement and confirmed by the Grant Agreement are hereby automatically, immediately and forever terminated, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Note Collateral Agent in such Trademarks hereby cease and are void.



The Note Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Company. This Release shall be construed in accordance with and governed by the laws of the State of New York.
