**RELEASE OF SECURITY INTEREST IN INTELLECTUAL
PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the "Release") is made as of October 9, 2017, by **MADISON CAPITAL FUNDING LLC**, as administrative agent for all Lenders that are party to the Credit Agreement as defined herein (the "Agent"), in favor of **MERIT ENTERPRISES, INC., AMI ENTERTAINMENT NETWORK, LLC, formerly known as Merit Industries, Inc. (the "Borrower") and then as AMI Entertainment Network, Inc., AMI ENTERTAINMENT, INC., MEGATOUGH, LLC** and all other Grantors under the Collateral Agreements (the "Grantors").

WHEREAS, the Borrower entered into that certain Credit Agreement, dated as of December 2, 2002, among certain of the Borrower, the Agent, and the Lenders (the "2002 Credit Agreement"), as such was amended and restated by that certain Amended and Restated Credit Agreement, dated as of March 29, 2007, among certain of the Borrower, the Agent, and the Lenders (the "2007 Credit Agreement"), as such was further amended and restated by that certain Second Amended and Restated Credit Agreement, dated as of April 13, 2009, among certain of the Borrower, the Agent, and the Lenders (the "2009 Credit Agreement," and together with the 2002 Credit Agreement and the 2007 Credit Agreement, and all annexes, exhibits or schedules thereto, as each may have been amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreements"), whereby the Lenders agreed to make certain loans and to extend certain letters of credit to the Borrower (collectively, the "Loans");

WHEREAS, pursuant to the Credit Agreements, and as a condition of the Lenders making the Loans, the Grantors entered into that certain Guarantee and Collateral Agreement, dated as of December 2, 2002, among certain of the Grantors and the Agent for the ratable benefit of the applicable Lenders (the "2002 Collateral Agreement"), as such was amended and restated by that certain Amended and Restated Guarantee and Collateral Agreement, dated as of April 13, 2009, among the Grantors and the Agent for the ratable benefit of the applicable Lenders (the "2009 Collateral Agreement" and together with the 2002 Collateral Agreement, and all annexes, exhibits or schedules thereto, as each may have been amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreements"), whereby the Grantors were obligated to enter into certain security agreements, instruments and documents in favor of Agent;

WHEREAS, in furtherance of the Credit Agreements and pursuant to the Collateral Agreements, the Grantors executed and delivered the following security agreements, instruments and documents in favor of Agent, including, without limitation, the following:

- (i) Patent Security Agreement, dated as of December 2, 2002, by Merit Industries Inc. (now known as AMI Entertainment Network, Inc.) in favor of Agent, as recorded in the U.S. Patent and Trademark Office (the "USPTO") on December 13, 2002 at Reel 013552/ Frame 0749;
- (ii) Trademark Security Agreement, dated as of December 2, 2002, by Merit Industries Inc. (now known as AMI Entertainment Network, Inc.) in favor of Agent, as recorded in the USPTO on December 13, 2002 at Reel 2627/ Frame 0354;
- (iii) Copyright Security Agreement, dated as of December 2, 2002, by Merit Industries Inc. in favor of Agent, as recorded in the U.S. Copyright Office (the "USCO") on April 7, 2003 at Document Number V3496D118;
- (iv) Reaffirmation of Security Documents, dated as of March 29, 2007, by Merit Industries Inc.

(now known as AMI Entertainment Network, Inc.) and Merit Enterprises, Inc. in favor of Agent, as recorded in the USPTO on April 5, 2007 at Reel 019120/ Frame 0940;

- (v) Amendment No. 1 to Copyright Security Agreement, dated as of March 29, 2007, by Merit Industries Inc. in favor of Agent, as recorded in the USCO on April 9, 2007 at Document Number V3550D904;
- (vi) Amendment No. 1 to Patent Security Agreement, dated as of April 13, 2009, by AMI Entertainment Network, Inc. in favor of Agent, as recorded in the USPTO on May 1, 2009 at Reel 022619/ Frame 0684;
- (vii) Amendment No. 1 to Trademark Security Agreement, dated as of April 13, 2009, by AMI Entertainment Network, Inc. in favor of Agent, as recorded in the USPTO on May 1, 2009 at Reel 3980/ Frame 0109;
- (viii) Amendment No. 2 to Copyright Security Agreement, dated as of April 13, 2009, by AMI Entertainment Network, Inc. in favor of Agent, as recorded in the USCO on June 19, 2009 at Document Number V3578D355;
- (ix) Patent Security Agreement, dated as of March 1, 2013, by Megatouch, LLC in favor of Agent, as recorded in the USPTO on March 21, 2013 at Reel 030063/ Frame 0084;
- (x) Copyright Security Agreement, dated as of March 1, 2013, by Megatouch, LLC in favor of Agent, as recorded in the USCO on March 22, 2013 at Document Number V3615D142;
- (xi) Trademark Security Agreement, dated as of March 1, 2013, by Megatouch, LLC in favor of Agent, as recorded in the USPTO on March 25, 2013 at Reel 4989/ Frame 0172 (collectively, the "Intellectual Property Security Agreements");

WHEREAS, pursuant to the Intellectual Property Security Agreements, the Grantors granted the Agent, on behalf of itself and the Lenders, a continuing security interest in all of each applicable Grantor's right, title and interest in, to and under certain intellectual property Collateral, including, without limitation, the patents and patent applications, trademark registrations and applications for trademark registration, and copyright registrations identified on Exhibit 1 attached hereto (collectively, the "Intellectual Property Collateral");

WHEREAS, the Grantors have satisfied in full the terms of the Credit Agreements and Collateral Agreements and have requested that the Agent, on behalf of itself and the Lenders, (a) terminate and release the security interest in the Intellectual Property Collateral, and (b) provide a document suitable for recording in the USPTO and the USCO for the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral; and

WHEREAS, the Loans and all other obligations under the Credit Agreements and Collateral Agreements have been paid in full or fulfilled, and there are no outstanding obligations remaining due and owing Credit Agreements and Collateral Agreements, which have been terminated, the Agent, on behalf of itself and the Lenders, desires to terminate and grant a release of its security interest in the Intellectual Property Collateral and to terminate and release the Intellectual Property Security Agreements as provided in this Release.

NOW THEREFORE, for good and valuable consideration previously tendered by the Grantors, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself and the Lenders, does hereby agree as follows:

1. The Agent, on behalf of itself and the Lenders, hereby: (a) terminates the Intellectual Property Security Agreements; (b) releases, relinquishes, terminates and discharges, without recourse, its security interest in the Intellectual Property Collateral in its entirety; and (c) retransfers and reassigns to the Grantors any and all right, title and interest of any nature whatsoever which it may hold in, to or under any of the Intellectual Property Collateral, including, without limitation, the patents and patent applications, trademark registrations and applications for trademark registration, and copyright registrations identified on Exhibit 1 attached hereto, and all associated common law rights and goodwill appurtenant thereto.

2. The Agent, on behalf of itself and the Lenders, authorizes the Grantors to record this Release with the USPTO, USCO and any other applicable governmental authority.

3. At the reasonable request and sole expense of the Grantors, the Agent, on behalf of itself and the Lenders, agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.


