RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of October 12, 2017 (this "Release") is made by Comerica Bank, as Administrative Agent, a Texas banking association, formerly a Michigan banking corporation (the "Secured Party"), under the Amended and Restated Security Agreement dated as of January 28, 2005 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between Plastipak Holdings, Inc., Plastipak Packaging, Inc., Whiteline Express, Ltd., Clean Tech, Inc., and Tabb Realty, LLC (collectively, the "Debtors") and the Secured Party, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 3146, Frame 0486.

WHEREAS, pursuant to the Security Agreement, the Debtors granted to the Secured Party a continuing security interest ("Security Interest") in the Debtors' trademarks, including but not limited to the trademarks listed on attached Exhibit A (the "Trademarks").

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its Security Interest covering the Trademarks; and (ii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its Security Interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
