WHEREAS, LENDER wishes to reassign all interest that LENDER may have in the Trademarks.

Agreement

Now, therefore, LENDER agrees that it releases its security interest in the Trademarks and reassigns to GRANTOR, without warranty or recourse, all interest of LENDER in the Trademarks.
