THEREFORE, Assignor and Assignee hereby agree as follows:

1. Assignment. As of the Effective Date, Assignor hereby assigns all registered trademark or trademarks pending registration identified above as well as any current or future unregistered common law trademarks for goods related to the Marks to reflect accurate ownership and origination of the Marks. The parties agree to execute and file with the USPTO whatever forms are necessary to effectuate the Assignment within thirty (30) days of the Effective Date.

2. Future Trademarks. All future trademarks related to the Marks will be filed under Assignee to reflect its ownership.

3. Unauthorized Use. Assignee agrees not to use the Marks to disparage, inaccurately represent, or mischaracterize Assignor and/or Assignee. Assignee further covenants to keep the use of the Marks consistent with the mission and brand of Assignee.

4. Term. This Assignment is effective as of the Effective Date and shall remain in effect in perpetuity (the "Term").

5. Miscellaneous. The Assignment represents the complete understanding between the parties with respect to the subject matter herein, and supersedes any other agreement or understanding related to the Marks. This Assignment may be modified only through a written instrument signed by both parties. In the event any provision of this Assignment is held by a court to be unenforceable, that provision will be reformed and enforced to the maximum extent possible under applicable law to reflect the intent of the parties captured in the recitals and terms, and the other provisions of this Assignment will remain in full force and effect. This Assignment shall be construed in accordance with and all disputes hereunder shall be governed by Nevada law, excluding its conflict of law rules and the parties hereby consent to the exclusive jurisdiction of the federal courts located in and for the County of Clark, Nevada. Each party has had the opportunity to be represented by counsel and no provision of this Assignment shall be construed against or interpreted to the disadvantage of any party by reason of such party having or being deemed to have drafted such provision.

WHEREFORE, intending to be bound, the parties have executed this Assignment through their authorized representative as of the dates set forth below.


