**CERTIFICATE OF AMENDMENT TO THE
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF
CLOSER MOBILE, INC.**

Closer Mobile, Inc., a corporation organized and existing under the laws of the State of Delaware (the "*Corporation*"), hereby certifies as follows:

1. The name of the Corporation is Closer Mobile, Inc. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on March 28, 2016.

2. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment (this "*Certificate of Amendment*") amends the provisions of the Corporation's current Amended and Restated Certificate of Incorporation (the "*Certificate of Incorporation*").

3. This Certificate of Amendment was duly adopted in accordance with Sections 242 of the General Corporation Law of the State of Delaware, and has been duly approved by the written consent of the stockholders of the Corporation in accordance with Section 228 of the General Corporation Law of the State of Delaware.

4. Article I of the Certificate of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:

"The name of the Corporation is Migo Inc.

5. The second and third paragraphs of Article IV of the Certificate of Incorporation of the Corporation are hereby amended and restated to read in their entirety as follows:

"The total number of shares of stock that the corporation shall have authority to issue is 25,274,456, consisting of (i) 16,000,000 shares of Common Stock, \$0.0001 par value per share ("*Common Stock*"), and (ii) 9,274,456 shares of Preferred Stock \$0.0001 par value per share."

"The first series of Preferred Stock shall be designated "*Series Seed 1 Preferred Stock*" and shall consist of 4,549,999 shares. The second series of Preferred Stock shall be designated "*Series Seed 2 Preferred Stock*" and shall consist of 4,724,457 shares. The Series Seed 1 Preferred Stock and Series Seed 2 Preferred Stock shall be collectively referred to herein as the "*Series Seed Preferred Stock*".

IN WITNESS WHEREOF, Closer Mobile, Inc. has caused this Certificate of Amendment to be signed by Jeff Warren, a duly authorized officer of the Corporation, on July 3, 2017.
