**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this 23<sup>rd</sup> day of October, 2017, is made by **ALOSTAR BANK OF COMMERCE**, a state banking institution organized under the laws of the State of Alabama, with an address at 3630 Peachtree Road, NE, Suite 1050, Atlanta, Georgia 30326, as lender (the "Lender").

**WITNESSETH**

WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of November 30, 2012 and recorded with the United States Patent and Trademark Office on November 30, 2012 at Reel 4910 Frame 0660 and on January 23, 2013 at Reel 4947 Frame 0567 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), made by Centennial Advisors, LLC, a Delaware limited liability company, formerly known as PMCO, L.L.C., a Delaware limited liability company (the "Grantor"), in favor of Grantee, and (ii) the Loan and Security Agreement (as defined in the Trademark Security Agreement), the Grantor pledged, granted and assigned to Grantee a continuing first priority security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including those trademarks listed on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby grants, assigns and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademark Collateral, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Trademark Collateral.
