**TERMINATION AND RELEASE OF GRANT OF
SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This Termination and Release of Grant of Security Interest in United States Trademarks (“Trademark Release”) is made as of October 24, 2017, by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH**, as Collateral Agent (the “Collateral Agent”), in favor of **RADIOLOGY 24/7, LLC**, a Delaware limited liability company with principal offices at 18201 Von Karman #600, Irvine, California 92612 (“Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, pursuant to that certain Security Agreement, dated June 3, 2013, made by Alliance Healthcare Services, Inc., in favor of the Collateral Agent, Grantor entered into that certain Grant of Security Interest in United States Trademarks, dated June 3, 2013 (the “Trademark Security Agreement”), with the Collateral Agent, notice of which was recorded on June 3, 2013 at the United States Patent and Trademark Office at Reel 5040, Frame 0249;

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to (i) all of Grantor’s Marks, including those listed in **Schedule A**, (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (collectively, the “Trademark Collateral”);


WHEREAS, the Collateral Agent has agreed to terminate and release the security interest in all such Trademark Collateral as herein provided;


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders and other holders of the Security Interest, hereby releases, terminates and discharges the Security Interest and any and all of its interest in the Trademark Collateral of Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
