TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is entered into and effective as of July 28, 2017, by Covidien LP, Delaware limited partnership ("Assignor"), in favor of KPR U.S., LLC ("Assignee"), a Delaware limited liability company.

WHEREAS, Medtronic plc ("Seller") and Cardinal Health, Inc. ("Buyer") have entered into a Stock and Asset Purchase Agreement, dated as of April 18, 2017, pertaining to the sale of certain assets owned by Seller and its Affiliates (as amended, supplemented or modified from time to time, the "Master Purchase Agreement"), pursuant to which, on the terms and subject to the conditions set forth in the Master Purchase Agreement, (a) Seller and the Selling Affiliates shall sell, assign, transfer and convey, to Buyer, and Buyer shall purchase, acquire and accept from Seller and the Selling Affiliates, all of Seller and the Selling Affiliates' right, title and interest in and to the Transferred Assets, and (b) Buyer shall assume and discharge and perform when due the Assumed Liabilities;

WHEREAS, Assignor is the owner of legal title to certain Trademarks included in the Transferred IP, including the Trademarks listed on Schedule A attached hereto (the "Assigned Marks") (for the avoidance of doubt, Trademarks listed on Schedule A shall be deemed to be Assigned Marks only to the extent included in the Transferred IP); and

WHEREAS, in furtherance of the Internal Restructuring Steps contemplated by the Master Purchase Agreement, Assignor and Assignee now desire to enter into this Assignment to effect the sale, assignment, transfer, conveyance and delivery to Assignee of the Assigned Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby irrevocably sells, assigns, transfers and conveys to Assignee, its successors and assigns, and Assignee hereby accepts the sale, assignment, transfer and conveyance of all of Assignor's rights, title and interests in and to the Assigned Marks, and, to the extent included in the Transferred IP, all of Assignor's rights, title and interests appurtenant thereto, including the goodwill associated therewith and which is symbolized thereby, all of Assignor's rights to bring a claim for past infringement and/or misappropriation with respect to the Assigned Marks, and any and all renewals and extensions thereof that are currently in effect in the United States, and in any other jurisdiction, in each case to the extent included in Transferred IP.
2. Assignor hereby requests the U.S. Commissioner of Patents and Trademarks and all other relevant trademark authorities throughout the world to record this Assignment, as to the Assigned Marks.
3. Subject to the terms and conditions of this Assignment, from and after the date hereof each party will execute and deliver, or cause its Affiliates to execute and deliver, all such documents and instruments and will take, or cause its Affiliates to take, all such further

actions, in each case as may be reasonably necessary to consummate the transactions contemplated by this Assignment.

4. This Assignment shall be governed by the law of the State of New York without reference to the choice of law doctrine of such state.
5. For the avoidance of doubt, no assets or rights (including any Trademarks) are being conveyed or otherwise transferred or assigned hereby unless and to the extent such Trademarks constitute Transferred IP. None of Assignor, Assignee or their respective Affiliates make any representations and warranties hereby.
6. If any provision of this Assignment (or any portion thereof) or the application of any such provision (or any portion thereof) to any person or circumstance shall be held invalid, illegal or unenforceable in any respect by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect any other provision hereof (or the remaining portion thereof) or the application of such provision to any other persons or circumstances. It is understood that any finding of invalidity of one assignment as effected hereby shall not affect the assignment of other Assigned Marks.
7. Capitalized terms used but not defined herein have the meanings set forth in the Master Purchase Agreement.
8. This Assignment may be executed in multiple counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same agreement. This Assignment may be executed by facsimile or electronic (.pdf) signature and a facsimile or electronic (.pdf) signature shall constitute an original for all purposes.
