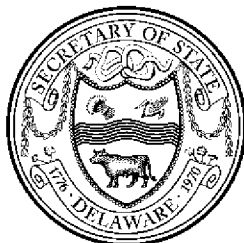



Pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "Act"), Questex Media Group LLC, a Delaware limited liability company (the "Company"), in connection with the merger (the "Merger") of Questex OpCo Merger Sub, LLC, a Delaware limited liability company ("Merger Sub"), with and into the Company, hereby certifies as follows:

FIRST: The names and states of domicile of the constituent limited liability companies to the Merger (the "Constituent Entities") are:
