And Section 209 of the Delaware Limited Liability Company Act

Pursuant to Section 264 of the General Corporation Law of the State of Delaware (the "DGCL") and Section 209 of the Delaware Limited Liability Company Act ("DLLCA"), Alphabet Acquisition Corp., a Delaware corporation (the "Company"), in connection with the merger of KLOS Syndications Assets, LLC, a Delaware limited liability company, with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The names and states of incorporation or formation, as applicable, of the Constituent Companies to the Merger (the "Constituent Companies") are as follows:

SECOND: An Agreement and Plan of Merger, dated September 30, 2014, by and among, the Constituent Companies (the "Merger Agreement"), setting forth the terms and conditions of the Merger, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Companies in accordance with Sections 141(f), 228 and 264 of the DGCL and Sections 209, 302(d) and 404(d) of the DLLCA.

THIRD: The Company shall be the surviving corporation of the Merger. The name of the surviving corporation is "Cumulus Network Holdings Inc." (the "Surviving Corporation").

FOURTH: Upon the effectiveness of the Merger, the certificate of incorporation of the Company in effect immediately prior to the Merger shall be the certificate of incorporation of the Surviving Corporation, except that Article One shall be amended in its entirety to read as follows:

The name of the corporation is Cumulus Network Holdings Inc. (hereinafter called the "Corporation").

FIFTH: The Merger shall become effective at 11:59 pm ET on September 30, 2014, upon the filing of a Certificate of Merger with the Secretary of State of the State of Delaware pursuant to the applicable provisions of the DGCL and the DLLCA, and such other documents as may be required by applicable law and the payment of all fees therefor, and the issuance by the Secretary of State of the State of Delaware of a certificate of merger in respect of the Merger.

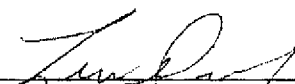
