TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") dated October 31, 2017 is made by the Persons listed on the signature pages hereof (collectively, the "Pledgors") in favor of Citizens Bank, National Association, as collateral agent (together with its permitted successors in such capacity the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, that certain Second Lien Credit Agreement, dated as of October 31, 2017 (as it may be amended, supplemented, restated or otherwise modified from time to time, the "Credit Agreement"), was entered into by and among ZeroChaos Parent, LLC, a Delaware limited liability company (the "Borrower"), Raptor Acquisition, LLC, a Delaware limited liability company ("Holdings"), the Lenders party hereto from time to time, Citizens Bank, National Association, as Administrative Agent (together with its permitted successors in such capacity, the "Administrative Agent").

WHEREAS, under the terms of the Second Lien Pledge and Security Agreement dated October 31, 2017 (the "Security Agreement"), the Pledgors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain trademarks of the Pledgors, and have agreed as a condition thereof to execute this Trademark Security Agreement for recording with the U.S. Patent and Trademark Office and any other appropriate domestic governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Pledgor agrees as follows:

Terms used but not otherwise defined herein are defined in the Credit Agreement or the Security Agreement, as applicable.

Grant of Security to Secured Parties. Each Pledgor hereby grants to the Collateral Agent for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in, to and under all Trademarks of such Pledgor, including those set forth on Schedule A attached hereto, in each case whether now owned or existing or hereafter acquired or arising and wherever located (all of which being hereinafter collectively referred to as the "Trademark Collateral").

Security for Obligations. The grant of a security interest in, the Collateral by each Pledgor under this Trademark Security Agreement secures the payment of all Secured Obligations (as defined in the Security Agreement) of such Pledgor now or hereafter existing under or in respect of the Collateral Documents (as such Collateral Documents may be amended, amended and restated, supplemented, replaced, refinanced or otherwise modified from time to time (including any increases of the principal amount outstanding thereunder)), whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise. Without limiting the generality of the foregoing, this Trademark Security Agreement secures, as to each Pledgor, the payment of all amounts that constitute part of the Secured Obligations (as defined in the Security Agreement) that would be owed by such Pledgor to any Secured Party under the Collateral Documents but for the fact that they are unenforceable or not allowable due to the existence of a bankruptcy, or reorganization or similar proceeding involving a Loan Party.

Recordation. Each Pledgor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Trademark Security Agreement.

Execution in Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


Grants, Rights and Remedies. This Trademark Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. Each Pledgor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

Governing Law. This Trademark Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.


