ASSIGNMENT OF PROPRIETARY RIGHTS

This **ASSIGNMENT OF PROPRIETARY RIGHTS** (this "Assignment"), dated as of March 6, 2017 and effective as of the Effective Time, by **ACTIVE DATA, INC.**, a Pennsylvania corporation (the "Seller"), in favor of **DUDE SOLUTIONS, INC.**, a Delaware corporation (the "Buyer"), is delivered in connection with the transactions contemplated by that certain Asset Purchase Agreement, dated as of the date hereof (the "Purchase Agreement"), between the Buyer, the Seller and Susan Yee. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Purchase Agreement.

For good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, and on the terms and subject to the conditions set forth in the Purchase Agreement and effective as of the Effective Time, the Seller does hereby contribute, convey, assign, transfer and deliver to the Buyer and its successors and assigns all of the Seller IP Rights (including without limitation the Marks "Active Calendar," and "Active Data Calendar"), together with the goodwill associated with such Seller IP Rights, the right, if any, to secure all registrations, renewals and extensions thereof in all countries, and the right to sue for and recover, and the right to profits or damages due, accrued, arising out of or in connection with any and all past, present or future infringements or dilution of, or damage or injury to such Seller IP Rights or the accompanying goodwill.

The Seller agrees that, upon the Buyer's reasonable request, it will furnish all necessary documentation reasonably available to the Seller relating to or supporting chain of title, sign all appropriate papers, take all rightful oaths and do all rightful acts that may be reasonably necessary for vesting title to and effecting the transfer and recording of the Seller IP Rights in the Buyer, its successors, assigns and legal representatives or nominees.

This Assignment is executed and delivered pursuant to, and is subject to the terms of, the Purchase Agreement, and nothing contained herein is intended to alter, modify, expand or diminish the terms set forth in the Purchase Agreement, including without limitation the representations and warranties relating to the Seller IP Rights.
