RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST, dated as of September 26, 2014, is made by ORIX VENTURES, LLC, a Delaware limited partnership (f/k/a ORIX Venture Finance LLC) ("Orix"), as collateral agent (the "Collateral Agent") in favor of Angie's List, Inc. a Delaware corporation (the "Grantor") as follows:

WITNESSETH

Reference is made to that certain Loan and Security Agreement, dated as of August 31, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit and Security Agreement"), by and among the Angie's List, Inc, as borrower, Orix, as lender and as Collateral Agent, and Bridge Bank, National Association ("Bridge Bank"), as lender. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Credit and Security Agreement;

WHEREAS, the Grantor entered into that certain Intellectual Property Security Agreement, dated as of August 31, 2011 (as supplemented from time to time the "IP Security Agreement"), in favor of the Collateral Agent pursuant to that certain Credit and Security Agreement, as collateral security for the prompt and complete payment and performance by the Angie's List Inc. of its Obligations under the Credit and Security Agreement;

WHEREAS, pursuant to the Credit and Security Agreement, the Grantor granted to the Collateral Agent a continuing first priority security interest in and to all of its right, title and interest in the Collateral including, without limitation, the trademarks set forth on Schedule 1 attached hereto, and recorded in the United States Patent and Trademark Office on August 31, 2011, reel: 4614, frame: 0989;

WHEREAS, pursuant to that certain Payoff Letter, dated as of the date hereof, the Collateral Agent and Bridge Bank acknowledge and agree that the Grantor has satisfied all of its monetary and other obligations owed to the Collateral Agent and Bridge Bank under the Credit and Security Agreement and the Grantor shall have no further obligation to Bridge Bank or the Collateral Agent under the Credit and Security Agreement.

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty and at the Company's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the Collateral.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be duly executed and delivered by its duly authorized officer as of the date first written above.
