**TRADEMARK ASSIGNMENT AND OWNERSHIP INTEREST  
TRANSFER AGREEMENT**

THIS AGREEMENT ("Agreement") is made by and between Rook Clothing Company, LLC ("Rook"), a California Limited Liability Company and Robby Khalek, ("Khalek") an individual doing business at 1939 South Susan Street, Santa Ana, CA 92704. Rook and Khalek shall sometimes be referred to collectively as "Parties."

WHEREAS Khalek is a member of, and the legal and beneficial owner of a 33.3% limited liability company interest (the "Khalek's Interest") in Rook, a limited liability company organized and existing under the laws of the State of California.

WHEREAS Rook is the rightful owner of the following trademark and trademark registration (the "Trademark"):

NOW THEREFORE, the Parties agree as follows:

THAT Khalek shall sell, assign, and transfer to Rook all of Khalek's Interest, free and clear of all liens, encumbrances, security interests, charges, indentures, pledges, options, voting trusts, restrictions and claims of any kind, and Rook agrees to accept Khalek's Interest;

THAT Rook shall assign and transfer unto Khalek all rights, titles and interests in the Trademark and Khalek agrees to acquire said Trademark;


NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Parties agree as follows:

1. Khalek sells, assigns, and transfers absolutely all titles and rights over Khalek's Interest to Rook. This transfer is absolute and includes all rights and obligations connected to the Khalek's Interest including but not limited to all rights to dividends, capital and voting rights.

2. Rook assigns to Khalek, his successors and assigns, all rights, titles and interests in said Trademark, the common law rights associated therewith, in the United States and worldwide, and all of the goodwill of the business associated with the use of and symbolized by said Trademark together with all claims for damages by reason of past, present, and future infringement of the rights assigned under this Trademark Assignment, with the right to sue for and collect the same for Khalek's use and benefit, and for the use and benefit of Khalek's successors, assigns, and other legal representatives.

This Agreement is effective as of October 23, 2017.




