ASSIGNMENT OF TRADEMARKS

WHEREAS, GLOBAL CONNECT HOLDING LIMITED, a Hong Kong Corporation with a present mailing address of 13/F, Gloucester Tower, The Landmark, 15 Queen's Road Central, Central, Hong Kong ("Assignee"), desires to acquire any and all rights that the Assignor has in and to the Mark, the application and any future applications therefore, together with the goodwill of the business symbolized by the Mark, along with the right to recover for damages and profits for past infringements thereof; and

WHEREAS, Assignee is the successor-in-interest to certain business interests of Assignor (including the Mark), for the purposes of 15 U.S.C. § 1060.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all right, title, and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, the registration and applications therefore, along with the right to recover for damages and profits for past infringements thereof.
