Trademark Assignment Agreement

WHEREAS, the Assignee wishes to acquire all of Assignor's rights in and to the Trademark and the goodwill associated therewith;

WHEREAS, this Agreement is drafted only for the purposes of filing a recordal of the assignment of the Trademark to the United States Patent and Trademark Office. This Agreement is only intended as an outline of the earlier agreement on the assignment of the Trademark (Agreement on Transfer of Trademarks and Domain Name), having the executive date of June 19th 2017, referred to as the "Earlier Agreement") between the Assignor and the Assignee and does not contain all of the conditions or clauses in the Earlier Agreement. Furthermore, this Agreement or its conditions do not modify, replace, substitute or supersede the Earlier Agreement or any of its conditions.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby assigns, transfers, and conveys to the Assignee all rights, title, and interest in and to the Trademark shown in Schedule A, together with the goodwill associated therewith, and with the right to recover for damages and profits and all other remedies for past infringements thereof.
