**TERMINATION AND RELEASE OF
FIRST LIEN TRADEMARK SECURITY AGREEMENT**

Termination and Release, dated as of November 1, 2017, by JPMORGAN CHASE BANK, N.A., a national banking association, located at 10 S. Dearborn, 7th Floor, Chicago, IL 60603, in its capacity as administrative agent pursuant to the Credit Agreement (in such capacity, the “**Administrative Agent**”), to FIBERTECH NETWORKS, LLC, a Delaware limited liability company, located at 300 Meridian Centre Blvd, Rochester, NY 14618 (“**Grantor**”).

W I T N E S S E T H:

WHEREAS, in connection with the First Lien Credit Agreement dated as of April 11, 2013 (as amended, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), the Grantor entered into a First Lien Security Agreement dated as of April 11, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) in favor of the Administrative Agent pursuant to which the Grantor executed and delivered that certain First Lien Trademark Security Agreement dated as of August 12, 2015 (the “**Trademark Security Agreement**”);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 12, 2015 at reel/frame number 5598/0714;

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

Section 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement and, if not defined therein, in the Credit Agreement.

Section 2. Release of Security Interest in Trademark Collateral. The Administrative Agent hereby releases the lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral (excluding any Excluded Assets) granted to the Administrative Agent under the Trademark Security Agreement:

(a) registered and applied for Trademarks of such Grantor listed on Schedule I attached hereto.
