

#### INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of October 20, 2017, is made by each of the entities listed on the signature pages hereof (each a "Grantor" and, collectively, the "Grantors"), in favour of BANK OF MONTREAL, in its capacity as administrative agent under the Loan Documents acting for and on behalf of itself and the Secured Parties (as defined below) (together with its successors and permitted assigns, the "Administrative Agent").

#### WITNESSETH:

**WHEREAS** pursuant to a Credit Agreement dated as of October 20, 2017, among goeasy Ltd., as borrower, the Administrative Agent, as administrative agent, the Lenders party thereto from time to time, as lenders, and others (as may be amended, restated, supplemented, renewed, replaced or otherwise modified from time to time, the "**Credit Agreement**"), the Lenders have agreed to extend certain credit facilities in favour of the Borrower subject to the terms and conditions set forth in the Credit Agreement;

**AND WHEREAS** each Grantor has entered into a general security agreement (each a "Security Agreement" and, collectively, the "Security Agreements") in favour of the Administrative Agent pursuant to which the Grantors are required to execute and deliver this Trademark Security Agreement;

**NOW THEREFORE** for good and valuable consideration, the receipt and sufficiency of which are conclusively acknowledged by each Grantor, each Grantor agrees and covenants with the Administrative Agent and the Secured Parties (as defined below) as follows:

#### 1. Defined Terms.

Capitalized terms used herein without definition are used as defined in the Credit Agreement. In addition, in this Trademark Security Agreement, unless the context otherwise requires, the following words and expressions shall have the meanings set forth below:

"Secured Parties" means the Administrative Agent, each Lender (and their Affiliates), each other Person having obligations secured under the Loan Documents, and in each case each of their respective successors and assigns and "Secured Party" means each of them; and

"Secured Obligations" means all Obligations of the Grantor.

#### 2. Grant of Security Interest in Trademark Collateral.

Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations hereby mortgages, pledges and hypothecates to the Administrative Agent for the benefit of the Secured Parties, and grants to Administrative Agent for the benefit of the Secured Parties an

Encumbrance on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the "**Trademark Collateral**"):

- (a) all of its trade-marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers (collectively, "**Trademarks**") and rights under any written agreement granting any right to use Trademarks, including, without limitation those Trademarks referred to on <u>Schedule 1</u> hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

## 3. Security Agreement.

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the applicable Security Agreement and each Grantor hereby acknowledges and agrees that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the applicable Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the applicable Security Agreement, the provisions of the applicable Security Agreement shall control.

#### 4. Grantor Remains Liable.

Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defence, enforcement or any other necessary or desirable actions in connection with their Trademarks subject to a security interest hereunder.

#### 5. Counterparts.

This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

#### 6. Governing Law.

This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the Province of Ontario and the federal laws of Canada applicable therein.
