TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of October 25, 2017 ("**Release**"), is made by Multiplier Capital, LP, a Delaware limited partnership (the "**Secured Party**"), in favor of Wilson Human Capital Group, Inc., a Delaware corporation (the "**Grantor**").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of August 9, 2016 by and between Grantor and Secured Party (as amended, "**Security Agreement**"), Grantor granted a continuing security interest to Secured Party in any and all right, title and interest of Grantor in, to and under the trademarks set forth on Exhibit A attached hereto (the "**Trademarks**"). A true and correct copy of the Security Agreement was recorded by the United States Patent and Trademark Office on August 9, 2016, at Reel 5849, Frame 0114;

WHEREAS, the Secured Party desires to release its security interest in the Trademarks and terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. terminates, cancels discharges and releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the Trademarks listed on Exhibit A attached hereto, and all of the goodwill associated thereto, without recourse or representation or warranty, express or implied
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the termination hereby given; and
3. authorizes the recordation of this Release.


