**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of November 12, 2015 (“Effective Date”), by **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company, in its capacity as agent for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors and assigns in such capacity, “Agent”), in favor of **REVERE HOLDING, INC.**, a Delaware corporation (“Parent”), **BULLHORN, INC.**, a Delaware corporation (“Borrower”), **BULLHORN GLOBAL, INC.**, a Delaware corporation (“Global”), **BULLHORN INTERNATIONAL, INC.**, a Delaware corporation (“International”), **LINDEN TECHNOLOGY HOLDINGS INC.**, a corporation incorporated under the laws of British Columbia, Canada (“Linden”), **MAXHIRE SOLUTIONS INC.**, a corporation incorporated under the laws of British Columbia, Canada (“MaxHire”), **SENDOUTS, LLC**, a Missouri limited liability company (“Sendouts”), and **EASY SOFTWARE SOLUTIONS, LLC**, a Virginia limited liability company (“Easy Software”); Parent, Borrower, Global, International, Linden, MaxHire, Sendouts, and Easy Software, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, reference is made to that certain Amended and Restated Credit Agreement, dated as of August 30, 2013 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Agent, Silicon Valley Bank, a California banking corporation, as syndication agent, Parent, and Borrower;

WHEREAS, pursuant to the terms and conditions of (1) that certain Trademark Security Agreement, dated as of June 13, 2012, by and among certain Grantors and Agent, which was recorded with the United States Patent and Trademark Office on June 13, 2012 at Reel 4800, Frame 0674, (2) that certain Amendment Number One to Trademark Security Agreement, dated as of November 26, 2012, by and among certain Grantors and Agent, which was recorded with the United States Patent and Trademark Office on November 26, 2012 at Reel 4906, Frame 0365, (3) that certain Amendment Number Two to Trademark Security Agreement, dated as of August 2, 2013, by and among Grantors and Agent, which was recorded with the United States Patent and Trademark Office on August 5, 2013 at Reel 5085, Frame 0425, and (4) that certain Amendment Number Three to Trademark Security Agreement, dated as of August 30, 2013, by and among Grantors and Agent (the documents set forth in items (1) through (4) above, as amended, restated, supplemented, or otherwise modified and in effect from time to time, collectively the “Trademark Security Agreement”), the Grantors granted to Agent a security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

WHEREAS, Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Agent in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
