**FIRST LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This First Lien Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of November 1, 2017, by DEUTSCHE BANK TRUST COMPANY AMERICAS, a New York trust company, in its capacity as administrative agent (the “Administrative Agent”) in favor of SATELLITE TRACKING OF PEOPLE LLC, a Delaware limited liability company with an address at 1212 N. Post Oak Road, Suite 100, Houston, Texas 77055 (and VERQUIS LLC, and SATELLITE TRACKING OF PEOPLE VQ) (collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain trademark security agreement dated December 20, 2013 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on December 20, 2013 at the United States Patent and Trademark Office at Reel 5180, Frame 0008.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantors granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to their Trademark Collateral, including the trademarks listed in Schedule I, and the goodwill connected with the use thereof and symbolized thereby.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its Security Interest in the Trademark Collateral of the Grantors, and the goodwill connected with the use thereof and symbolized thereby, and assigns, transfers and conveys to Grantors any right, title or interest the Administrative Agent may have in the foregoing.


