**WHEREAS**, pursuant to the terms and conditions of the following of the following trademark security instruments (collectively, the "Security Interest Grants"):

(i) that certain Memorandum of Trademarks and Goodwill, recorded with the United States Patent and Trademark Office (the "USPTO") on September 14, 2000, at **Reel 2164 Frame 0504**, made by Patagonia and Great Pacific in favor of the Secured Party, as amended by that certain First Amendment to Memorandum of Security Interest in Trademarks and Goodwill, recorded with the USPTO on October 25, 2001, at **Reel 2393 Frame 0647**, made by Patagonia and Great Pacific in favor of the Secured Party, as amended by that certain Second Amendment to Memorandum of Security Interest in Trademarks and Goodwill, recorded with the USPTO on January 23, 2004, at **Reel 2901 Frame 0224**, made by the Grantors in favor of the Secured Party, and as amended by that certain Third Amendment to Memorandum of Security Interest in Trademarks and Goodwill, recorded with the USPTO on December 22, 2009, at **Reel 4118 Frame 0684**, made by the Grantors in favor of the Secured Party;

(ii) that certain Intellectual Property Security Agreement, recorded with the USPTO on August 10, 1999, at **Reel 1942 Frame 0281**, made by Patagonia and Great Pacific in favor of Secured Party;

(iii) that certain Memorandum of Security Interest in Trademarks and Goodwill, recorded with the USPTO on August 10, 1999, at **Reel 1942 Frame 0161**, made by Patagonia and Great Pacific in favor of Secured Party;

(iv) that certain security agreement recorded with the USPTO on November 4, 1997, at **Reel 1662 Frame 0729**, made by Patagonia and Great Pacific in favor of Secured Party;

the Grantors pledged and assigned to Secured Party, a continuing security interest in all of the Grantors' right, title and interest in and to the trademarks and trademark registrations and applications therefor which are identified on Schedule 1 attached hereto, together with the goodwill and assets of the business owned by the Grantors which are appurtenant thereto and all actions for infringement concerning the foregoing (collectively, the "Trademark Collateral").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby (i) terminates the Security Interest Grants, (ii) releases, without any representation, recourse or undertaking by Secured Party, any and all liens on, and security interests in, the Trademark Collateral granted pursuant to the Security Interest Grants and (iii) authorizes the recordation of this Release by the Grantors or their designees with the USPTO.


