## ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS (this "Assignment") is entered into as of September 19, 2017, by and between Snap Capital LLC, a Delaware limited liability company ("Assignor"), and LendingTree, LLC, a Delaware limited liability company ("Assignee"). Capitalized terms used and not defined herein have the respective meanings ascribed to them in the Purchase Agreement (as defined hereinafter).

### RECITALS

A. Assignor owns the trademarks, trademark applications, patents and patent applications, copyrights and copyright applications and other Intellectual Property set forth on Exhibit A, and all registrations, issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof (the "Intellectual Property Assets").

B. Under the terms of that certain Asset Purchase Agreement, dated as of even date herewith (the "Purchase Agreement"), by and between Assignor and Assignee, Assignor has agreed to assign the Intellectual Property Assets to Assignee, subject to the terms and conditions hereof.

### AGREEMENT

NOW, THEREFORE, for good and valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers and assigns to Assignee and Assignee hereby accepts all of Assignor's right, title and interest in and to the Intellectual Property Assets, free and clear of any Liens other than Permitted Liens, together with all of Assignor's related common law rights in all jurisdictions; all rights to any royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect thereto; claims, causes of action and rights to recover with respect thereto, whether accruing before, on and/or after the date hereof, including all claims, causes of action and rights for damages and payments, restitution and injunctive and other legal and equitable relief for past, present or future infringements, violations, misuses or misappropriations, breaches or defaults thereof and the goodwill associated with the Intellectual Property Assets.

2. Assignor's Use and Enjoyment. The rights, title and interest assigned under Section 1 shall be for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

3. Rights to Record. Assignor hereby grants Assignee powers of attorney to file this Assignment before the relevant intellectual property authorities of any countries to effect the assignment of Intellectual Property Assets hereunder in the name of Assignee. Assignor hereby authorizes the officials of any such entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Following the date hereof, upon Buyer's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and other legal representatives, including the

execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documents, as may be necessary to effect, evidence or perfect the assignment of the Intellectual Property Assets to Assignee or any assignee or successor thereto.

4. Further Assurances. Each of the parties hereto agrees to cooperate and to execute and deliver to the other parties such further instruments, and to take such further actions, as may be reasonably requested by such other parties to evidence and reflect the transactions contemplated by this Assignment.

5. Conflicts and Inconsistencies. This Assignment is executed and delivered by Assignor and Assignee pursuant to the Purchase Agreement, subject to the covenants, representations and warranties thereof. No provisions set forth herein shall be deemed to enlarge, expand, alter or amend the terms or provisions of the Purchase Agreement. In the event of any conflict between the provisions herein and the Purchase Agreement, the provisions of the Purchase Agreement shall control.

6. Successors and Assigns. Assignor may not assign any of its rights or obligations hereunder without the prior written consent of Assignee. Any assignment in violation of this provision will be void. This Assignment will be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.

7. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware, without regard to the principles of conflicts of law thereof.

8. Counterparts. This Assignment may be executed in any number of counterparts (and by facsimile or other electronic transmission copy), each of which will be an original as regards to any party whose signature appears thereon and all of which together will constitute one and the same instrument. This Assignment will become binding when one or more counterparts hereof, individually or taken together, will bear the signatures of all parties reflected hereon as signatories.


