FURTHER, Assignor does hereby assign to Assignee all income, royalties or payments due or payable in respect of the Trademarks as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks, with right to sue for and collect the same for Assignee’s own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.


FURTHER, Assignor hereby agrees to assist Assignee and Assignee’s successors, assigns or other legal representatives (each an “**Assignee Party**”) in prosecuting, maintaining, renewing, enforcing and defending such Trademarks as and when reasonably requested by an Assignee Party and at such Assignee Party’s sole cost and expense.

Assignor requests that the Commissioner for Trademarks or corresponding agencies in all applicable jurisdictions record Assignee as the assignee and owner of each of the Trademarks and registrations therefor.

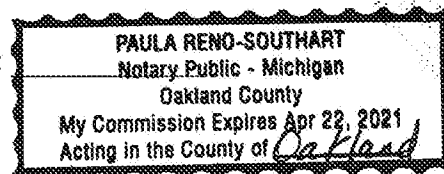
