## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement dated July 31, 2017 ("Effective Date") is made by and between:

Phantom I.P. LLC, a Delaware limited liability company with an address at 2445 Belmont Ave, Youngstown, Ohio 44505-2445 (together with its successors and permitted assigns "Phantom IP" or "Assignor"); and



The Parties agree as follows:

1. **Assignment by Phantom IP.** For the good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Phantom IP does hereby assign and irrevocably grant to Superior all right, title and interest throughout the world in the intellectual property rights to the Superior Storm trademark, together with all registrations including Serial No. 2,570,437, Registration No. 76183746 ("Superior Storm Trademark") and the goodwill of the business connected with the use and symbolized by the trademark, all reproduction and allied rights necessary for production, distribution and exploitation thereof, all translations, adaptations and other versions thereof now made or hereafter created.
2. **Transfer of Rights.** This Agreement shall be binding on the successors and assigns of the parties.
3. **Complete Contract.** It is understood and agreed that this Agreement is the full complete and final contract. There are no written or oral understandings or agreements directly or indirectly connected with this contract that are not incorporated herein.
4. **No Oral Modification.** This Agreement may not be modified orally. Any amendment to this Agreement must be in writing and be signed by all parties.
5. **Severability.** Should any provision of this Agreement be held unenforceable or in conflict with the law of any jurisdiction where its enforcement is sought, the remaining provisions of this Agreement shall still be given effect and be enforced to the maximum practicable extent.


- 6. **Counterparts.** This Agreement may be executed in two or more counterparts.
