## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of November 6, 2017 (this "Release") is made by The Huntington National Bank, as Administrative Agent (the "Secured Party"), under the Agreement (Trademark) dated as of December 21, 2012 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between Ramsey Industries, Inc., Ramsey Winch Company, Auto Crane Company, Eskridge, Inc. and Ramsey Holdings, Inc.
