

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR agrees that ASSIGNOR hereby assigned unto ASIGNEE *nunc pro tunc* effective as of 12.09.2017, all right title and interest in and to the trademark SCAPA described herein, the registration thereof, together with all derivations thereof and including all goodwill associated therewith, whether based on common law or the laws of the various states, and the right (but not the obligation) to assert such registered trademark and other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties, and proceeds of infringement suits and all rights corresponding thereto through the world by reason of any past and future acts of infringement that have occurred or may occur.
