RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of November 7, 2017 (“Effective Date”) by ARES CAPITAL CORPORATION, a Maryland corporation, in its capacity as Agent (the “Agent”) for the Lenders, in favor of YOUNG PS ACQUISITIONS, LLC, a Delaware Limited Liability Company, YOUNG OS LLC, a Delaware Limited Liability Company, YOUNG DENTAL MANUFACTURING I, LLC, a Missouri Limited Liability Company, YOUNG MICROBRUSH, LLC, a Delaware Limited Liability Company, PANORAMIC RENTAL CORP., a Missouri Corporation, YOUNG INNOVATIONS, INC., a Missouri Corporation, and AMERICAN EAGLE INSTRUMENTS, LLC, a Delaware Limited Liability Company (“Borrowers”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Amended and Restated Guarantee and Collateral Agreement (as defined below).

W I T N E S S E T H

WHEREAS, pursuant to that certain Second Lien Guarantee and Collateral Agreement, dated as of May 30, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, including by joinder, the “Guarantee and Collateral Agreement”), among the Borrowers, the Agent, the Lenders (as defined in the Credit Agreement (as defined below)) and the other loan parties thereto, Borrowers has granted to Agent, for its benefit and the benefit of Lenders, a security interest and lien upon substantially all assets of Grantor (as defined below), including all right, title and interest of Borrowers in, to and under all now owned and hereafter acquired Trademarks (as defined in the Guarantee and Collateral Agreement including registrations and applications thereof, and all applications in connection therewith), together with the goodwill of the business symbolized by Grantor’s Trademarks, and all proceeds thereof, to secure the payment of all amounts owing by Borrowers pursuant to the terms and conditions set forth in the Second Lien Credit Agreement, dated as of May 30, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among the Borrowers, Agent, the Lenders, and the other loan parties thereto.

WHEREAS, pursuant to the Guarantee and Collateral Agreement, that certain Trademark Security Agreement and Amended and Restated Trademark Security Agreements, dated as of May 3, 2017, were made by the Borrowers as grantors (the “Grantors”) and the Agent as grantee (the “Trademark Security Agreements”), to record the security interest with respect to the Trademark Collateral (as defined in the Trademark Security Agreements) of Grantors, including those items set forth on Schedule A hereto, and were recorded with the Trademark Division of the United States Patent and Trademark Office (i) on June 4, 2014 as Reel/Frame 5296/0015, Reel/Frame 5295/0768, Reel/Frame 5295/0983, Reel/Frame 5296/0050, Reel/Frame 5296/0137 Reel/Frame 5295/0845, Reel/Frame 5295/0869, and Reel/Frame 5295/0751, (ii) May 3, 2017 as Reel 6051 and Frame 0224, (iii) on September 29, 2017 as Reel 6166 and Frame 0271, and Reel 6166 and Frame 0286, and (iii) filed on October 9, 2017; and

WHEREAS, Grantors have satisfied the terms of the Guarantee and Collateral Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, pursuant to the terms of that certain payoff letter, dated as of the date hereof, by and among, the Agent, the Lenders, the Borrower and other parties thereto, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Lenders, without recourse, representation, warranty or other assurance of any kind by the Agent (express or implied) as to the Agent's rights in any Trademarks, the condition or value of any Trademarks, (i) terminates the Trademark Security Agreements and releases, discharges and cancels and re-assigns to each Grantor any and all liens, security interests, right, title and interest it may have in, to and under any and all Trademark Collateral, including those items set forth on Schedule A hereto, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts reasonably requested by each Grantor to relinquish and effect the release of such rights to such Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent's rights under the Guarantee and Collateral Agreement with respect to the Trademark Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
