## RELEASE OF SECURITY INTEREST

**THIS RELEASE OF SECURITY INTEREST** (this "Release") is made as of September 1, 2017 ("Effective Date"), by Pacific Western Bank, a California state chartered bank and successor in interest by merger to Square 1 Bank ("Bank"), in favor of eBay Inc., a Delaware corporation ("eBay").

**WHEREAS**, Bank, on the one hand, and Formation Data Systems, Inc., a Delaware corporation ("Debtor"), on the other hand, are parties to that certain Loan and Security Agreement dated as of July 18, 2014 (such agreement, as amended, supplemented or modified, together with all documents, instruments and agreements related thereto, may be collectively referred to herein as the "Loan Documents");

**WHEREAS**, in order to secure Debtor's prompt payment and performance of its obligations under the Loan Documents, Debtor granted to Bank, and Bank currently possesses, a security interest in and lien upon, among other collateral, all of Debtor's right, title and interest in and to (i) the United States trademark registration listed on Schedule A hereto, including any and all goodwill associated with the use of, and symbolized by, such registered trademark, and any and all trademark rights therein (the "Trademark") and (ii) the United States patent registrations and patent applications listed on Schedule B hereto (the "Patents");

**WHEREAS**, pursuant to the Loan Documents, Debtor and Bank entered into (i) an Intellectual Property Security Agreement dated May 17, 2017 (the "Security Agreement") for purposes of recording with the United States Patent and Trademark Office ("USPTO") and (ii) a Supplement to the Security Agreement dated August 22, 2017 (the "Security Agreement Supplement") for purposes of recording with the USPTO;

**WHEREAS**, the Security Agreement was recorded in the USPTO on May 30, 2017 at each of Trademark Reel 006072/Frame 0212 and Patent Reel 042527/Frame 0021;

**WHEREAS**, the Security Agreement Supplement was recorded in the USPTO on August 22, 2017 at Patent Reel 043352/Frame 0541;

**WHEREAS**, one or more Events of Default (as defined in the Loan Documents) has occurred and is continuing, and under the terms of the Loan Documents, such Events of Default entitle Bank to sell Debtor's right, title and interest in and to the Trademark and Patents in a foreclosure sale in accordance with the Uniform Commercial Code (the "Code");

**WHEREAS**, Debtor has acknowledged such Event of Default and Bank's right to sell Debtor's right, title and interest in and to the Trademark and Patents pursuant to the Loan Documents and the Code, and Debtor has given Bank its consent to such sale;

**WHEREAS**, Bank and eBay have entered into an Asset Purchase Agreement of substantially even date herewith ("Purchase Agreement") pursuant to which Bank is selling all of Bank's and Debtor's right, title and interest in and to the Trademark and Patents to eBay; and

**WHEREAS**, Bank wishes to release its security interest in the Trademark and Patents.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby terminates, releases and discharges any security interest in and lien upon the Trademark and Patents that Bank may possess.
2. Bank agrees to take all further actions, and provide to eBay and its successors, assigns and legal representatives, all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as eBay and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

**IN WITNESS WHEREOF**, Bank has caused this Release to be executed by its duly authorized representative effective as of the Effective Date.
