RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

November 1, 2017

WHEREAS, GOEASY LTD., a corporation formed under the laws of the Province of Ontario (formerly known as EASYHOME LTD.), RTO Asset Management Inc. and easyfinancial Services Inc., as borrowers, easyfinancial Mortgages Inc., easyfinancial Services (UK) Ltd. and easyhome U.S. Ltd., as guarantors, and CRYSTAL FINANCIAL LLC, as administrative agent (the "Administrative Agent") for its own benefit and the benefit of the other Lenders, entered into that certain credit agreement dated as of July 28, 2014 (as amended or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to the terms of the Credit Agreement, EASYFINANCIAL SERVICES INC. (the "Company") and the Administrative Agent for its own benefit and the benefit of the other Lenders, entered into that certain Patent and Trademark Security Agreement, dated as of July 28, 2014 (as amended or otherwise modified from time to time, the "Patent and Trademark Security Agreement"); capitalized terms used herein without definition shall have the meanings assigned to such terms in the Patent and Trademark Security Agreement);

WHEREAS, pursuant to the Patent and Trademark Security Agreement and the other Loan Documents (as defined in the Credit Agreement), the Company granted to the Administrative Agent a security interest in all of the Company's Patents and Trademarks, including those patents shown on Exhibit A hereto and trademarks shown on Exhibit B hereto;


WHEREAS, the Administrative Agent filed the Patent and Trademark Security Agreement with the United States Patent and Trademark Office (the "PTO") on August 8, 2014 at Reel 5340, Frame 0001;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates and releases, without representation or warranty, its Security Interest in all of the Patents, including, without limitation, those patents identified on Exhibit A attached hereto and Trademarks, including, without limitation, those trademarks identified on Exhibit B attached hereto, effective as of the date first set forth above.

This release may be executed in any number of counterparts, but all of such counterparts shall together constitute but one and the same agreement. Delivery of an executed signature page of this release by electronic transmission shall be as effective as delivery of a manually executed counterpart hereof. The Administrative Agent acknowledges that this release may be filed with the PTO to evidence the termination and release granted herein.
