TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Termination and Release”), effective as of November 8, 2017, is made by Royal Bank of Canada, a bank organized under the laws of Canada, located at 20 King Street West, 4th Floor, Toronto, Ontario M5H1C4, Attention: Manager, Agency Services Group, as Administrative Agent (the “Agent”) for the Secured Parties (as defined in the Security Agreement), to (i) LinkOffers, Inc., a Delaware corporation, located at 9430 Research Blvd., Austin, Texas 78759, and (ii) Bankrate, Inc., a Delaware corporation, located at 11760 U.S. Highway One, Suite 200, North Palm Beach, Florida 33408 (each a “Grantor” and collectively the “Grantors”).

W I T N E S S E T H:

WHEREAS, in connection with the Revolving Credit Agreement dated as of August 7, 2013 (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the “Revolving Credit Agreement”), the Grantors executed and delivered a Security Agreement, dated as of August 7, 2013, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Security Agreement”);

WHEREAS, in connection with the Security Agreement, the Grantors authorized the execution, delivery and performance of that certain Grant of Security Interest in Trademark Rights, dated as of August 7, 2013, which was recorded in the Trademark Division of the United States Patent and Trademark Office on August 14, 2013, at reel/frame number 5089/0612;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Agent hereby releases its security interest in (a) each Grantor’s right, title and interest in the Trademarks of such Grantor (including, without limitation, those items listed on Schedule A hereto), (b) all goodwill of the business associated with the Trademarks, and (c) all rights to sue at law or in equity for any infringement, other violation or impairment thereof arising prior to or after the date hereof (collectively, the “Collateral”).


SECTION 3. Further Assurances. The Agent hereby agrees, at the Grantors’ joint and several expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.

SECTION 4. Governing Law. THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
