RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), is dated as of August 1, 2017, and made by JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, a banking association chartered under the laws of the United States of America having an address at 10 S. Dearborn, 7th Floor, Chicago, IL 60603 and GERMAN AMERICAN CAPITAL CORPORATION, a Maryland corporation having an address at 60 Wall Street, New York, NY 10005 (together with its respective successors and assigns, each a "Co-Lender" and, collectively, the "Lenders").

WHEREAS, pursuant to a Trademark Security Agreement dated as of January 30, 2015, (the "Trademark Security Agreement"), made by G6 Hospitality IP LLC, a Delaware limited liability company ("G6") in favor of the Lenders, a security interest in all of G6's right, title and interest in, to and under certain collateral was granted by G6 to the Lenders (the "Security Interest"), including in the United States registered Trademarks (as defined therein) and Trademarks for which United States applications are pending, as set forth in Schedule A thereto (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 30, 2015, at Reel 5450 and Frame 0075;

WHEREAS, Lenders now desires to release the Trademark Security Agreement and its Security Interest in all of G6's right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Lenders hereby state as follows:

1. Release of Lien and Security Interest. Lenders hereby terminate, release and discharge their lien on and Security Interest in and to all of G6's right, title and interest in, to and under the Trademark Collateral, including all of the United States registered Trademarks and Trademarks for which United States applications are pending referred to on Schedule A hereto, that was granted to Lenders pursuant to the Trademark Security Agreement, and any right, title or interest of the Lenders in such Trademark Collateral shall hereby cease and become void.

2. Further Assurances. The Lenders hereby agree that, at the sole cost and expense of G6, they will duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to evidence the release, termination and discharge of the lien and Security Interest effected hereby.

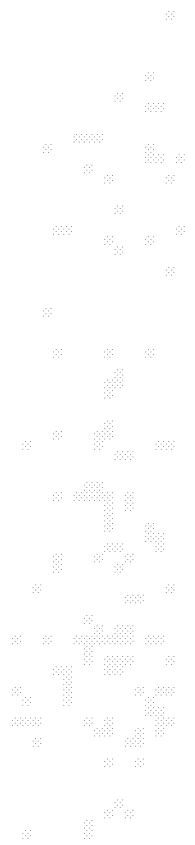
