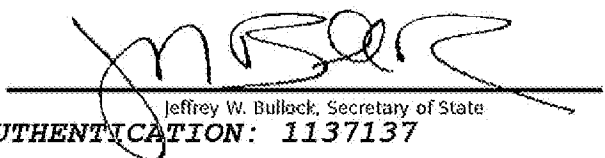

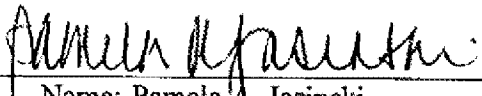
FIRST: Article FIRST of the Certificate of Incorporation of the Corporation is deleted in its entirety and the following new Article FIRST is inserted in its place:
