INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION is made effective as of October ~~30~~³¹, 2017, by and among Wells Fargo Business Credit, Inc., a Minnesota corporation and successor in interest to Norwest Business Credit, Inc. ("**Secured Party**"), Tejas PB Distributing, Inc., an Arizona corporation ("**Tejas**") and Inventure Foods, Inc., a Delaware corporation (formerly known as Poore Brothers, Inc.) as successor-in-merger to Poore Brothers Arizona, Inc., an Arizona corporation and Poore Brothers Distributing, Inc., an Arizona corporation (collectively, "**Poore Brothers**" and, together with Tejas, the "**Company**"). Capitalized terms used but not defined herein shall have the meanings given them in the Security Agreement (as defined below).

WHEREAS, the Company and Secured Party entered into (i) that certain Credit and Security Agreement, dated as of October 23, 1998 (the "**Credit Agreement**") and (ii) that certain Patent and Trademark Security Agreement, dated as of October 23, 1998 (the "**Security Agreement**");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on December 9, 1998, at Reel 1824, Frame 0049;

WHEREAS, pursuant to the Security Agreement and the Credit Agreement, the Company granted Secured Party a security interest in all of Debtor's right, title and interest in, to and under the patents listed on the attached Exhibit A (the "**Patents**") and the trademarks listed on the attached Exhibit B (the "**Trademarks**") (collectively, the "**Intellectual Property**");

WHEREAS, the Company has or has caused to be paid and satisfied in full the obligations for which the security interest in the Intellectual Property was granted; and


WHEREAS, the Secured Party wishes to release its security interest in the Intellectual Property;

NOW, THEREFORE, the parties agree that Secured Party hereby releases any security interest it may have in the Intellectual Property and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns to the Company all right, title and interest in the Intellectual Property it may have in and to the foregoing without recourse to the Company. The Secured Party further agrees, for itself, its successors and assigns, to execute, at the Company's expense, such further documents, and to perform such further lawful acts, as may reasonably be requested by the Company to effectuate this termination.






