## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of November 1, 2017 (this "Release") is made by Comerica Bank, as agent (the "Secured Party") under the U.S. IP Agreement (Trademark) dated as of August 29, 2008 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between Strategic Materials, Inc., NexCycle, Inc. and Contain-A-Way, Inc. (each, a "Debtor" and together, the "Debtors") and the Secured Party, and recorded in the records of the United States Patent and Trademark Office on September 16, 2008 at Reel 3853, Frame 886.

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Debtors; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.


