Service mark Assignment Agreement

This Service mark Assignment Agreement (the "Agreement") is made as of this 10th day of November 2017 (the "Effective Date"), between Corporate Environmental Solutions LLC as the original Federal service mark registration applicant/owner, (hereafter the "Assignor"), and CES Clean Water LLC, having a business address at 779 Pine Valley Drive, Pittsburgh Pennsylvania 15239, as the future trademark owner (the "Assignee").

The Assignor is the owner of the service mark, CES Clean Water, for which Federal Registration was granted on February 7, 2017 as Registration No. 5,137,090 (hereinafter, the "Service Mark").

The Assignor may also have common law trademark rights in the aforesaid even if it has not registered a mark or trade name that it has been using as part of its business. The Assignor's common law service mark may also have significant monetary value.

The Assignee wishes to acquire all of the Assignor's rights in the Service Mark listed in this agreement, both Federal registration rights and common law rights PLUS any and all goodwill associated with the same.

The Assignee agrees to pay the Assignor one U.S. dollar (\$1.00) plus other good and valuable consideration past receipt of which is hereby expressly acknowledged.

In exchange for the foregoing, the Assignor hereby conveys, transfers, and assigns to the Assignee all of the Assignor's right, title, and interest of whatever kind in the Service Mark, together with:

- 1) the goodwill of the business relating to the products and/or services on which the Service Mark is used and for which it is registered;
- 2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Service Mark including, without limitation, damages, and payments for past or future infringements and misappropriations of the Service Mark; and
- 3) all rights to sue for past, present and future infringement or misappropriations of the Service Mark.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Service Mark and its related property.
