RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated November 1, 2017, is made by and between **NEKOOSA COATED PRODUCTS, LLC**, a Delaware limited liability company (“Debtor”), successor by conversion to Nekoosa Coated Products, LLC, a Wisconsin limited liability company, which was the successor by merger to Nekoosa Acquisitions, LLC, a Delaware limited liability company, whose principal place of business and mailing address is 841 Market Street, Nekoosa, Wisconsin 54457, and **FIFTH THIRD BANK**, an Ohio banking corporation, as Agent for the benefit of the Secured Creditors (as defined in the Credit Agreement) (“Agent”). All capitalized terms not herein defined shall have the same meaning prescribed in the Trademark Security Agreement, dated as of October 2, 2012, the Amended and Restated Trademark Security Agreement, dated as of April 22, 2013, and the First Amendment to Amended and Restated Trademark Security Agreement, dated as of January 18, 2017 between Agent and Debtor (the “Security Agreements”), as applicable.

WHEREAS, Agent and Debtor, are parties to that certain Security Agreements, which were recorded with the United States Patent and Trademark Office on October 5, 2012, at Reel 4875, Frame 0021, on April 23, 2013, at Reel 5012, Frame 0249, and on February 3, 2017, at Reel 5981, Frame 0255;

WHEREAS, the Security Agreements granted to Agent a continuing security interest in and to, all of Debtors’ rights, titles and interests in and to all of its Trademark Collateral, including without limitation those Trademarks listed on Schedule I attached hereto, and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby, on behalf of itself and the Secured Creditors, fully and finally (a) terminates the Agreement, (b) releases and terminates its security interest and all other rights in and to the Trademark Collateral, and (c) re-assigns to Debtor, any right, title or interest the Secured Party or any Secured Creditor may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby.
