GRANT OF FIRST LIEN SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, each of Alliance HealthCare Services, Inc., Alliance Oncology, LLC, and USR Holdings, LLC (each, a “Grantor” and collectively, the “Grantors”), each with principal offices at 18201 Von Karman #600, Irvine, California 92612, hereby grants to JPMorgan Chase Bank, N.A., as Collateral Agent (as defined in the Security Agreement referred to below) (the “Grantee”), a continuing security interest in (i) all of such Grantor’s right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations of each Grantor, as such term is defined in the First Lien Security Agreement among the Grantors, the other grantors from time to time party thereto and the Grantee, dated as of October 24, 2017, (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”). Promptly following the request by the Grantor after the occurrence of the Termination Date (as defined in the Security Agreement), the Grantee shall execute and deliver to the Grantors an instrument in writing releasing the security interest in the Marks acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern. For the avoidance of doubt, this agreement is subject to Section 8.15 of the Security Agreement.
