TRADEMARK ASSIGNMENT

This Confirmatory Assignment of Trademarks, is made as of November 9, 2017 (this "Assignment"), by and between Kronos Foods Corp., an Illinois corporation ("Seller"), and Sinbad Foods, LLC, a Delaware Limited Liability Company ("Sinbad"). Both Seller and Sinbad are collectively referred to herein as the "Parties."

WHEREAS, Seller and Sinbad entered into an Asset Purchase Agreement dated as of April 11, 2017 (the "Agreement"), pursuant to which Seller conveyed to Sinbad all of its right, title and interest in and to its Madera Facility and Rain Creek Baking line of business ("Business");

WHEREAS, as part of the Agreement, Seller conveyed all of its right, title, and interest in and to the trademarks owned by Seller and affiliated with the Business, shown on Schedule A, and the goodwill of the business in connection therewith (collectively, the "Trademarks");

WHEREAS, Seller and Sinbad wish to confirm that Schedule A lists the transferred Trademarks in and to which all right, title, and interest were effectively and irrevocably transferred from Seller to Sinbad; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:



Seller hereby sells, transfers, conveys, assigns and delivers to Sinbad its entire right, title, and interests in, to and under all Trademarks, together with the goodwill of the business symbolized by such Trademarks, together with all rights and privileges granted and secured thereby, including the full right to sue for past, present or future infringement on such Trademarks, these rights to be held and enjoyed by Sinbad as fully and entirely as the same would have been held by Seller if this Assignment and sale had not been made.
2. The Parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office to record Sinbad as the assignee and owner of the Trademarks.
3. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns.
