AFFIDAVIT TO AFFIRM SECURITY INTERESTS RECORDED IN ERROR

This Affidavit to Affirm Security Interests Recorded In Error is effective as of November 3, 2017.

I, Andrew Church, do hereby declare as follows:

1. I am the Chief Financial Officer and Secretary of Woodstream Corporation, a Pennsylvania corporation, located at 69 North Locust Street, Lititz, Pennsylvania 17543 (the "Company").
2. American Biophysics Corp. ("Grantor") executed that certain Security Agreement dated as of March 20, 2006 (the "ROF Security Agreement") pursuant to which Grantor pledged, assigned and granted to RAM Opportunity Fund I, L.L.C. a security interest in all of Grantor's right, title and interest in, to and under the trademark registrations set forth on Schedule A attached hereto (the "Scheduled Trademarks").
3. Grantor executed that certain Intellectual Property Security Agreement dated as of April 17, 2006 (the "SVB Security Agreement" and, together with the ROF Security Agreement, the "Security Agreements") pursuant to which Grantor granted to Silicon Valley Bank a security interest in all of Grantor's right, title and interest in, to and under the Scheduled Trademarks.
4. The ROF Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on April 21, 2006 at Reel 3295, Frame 0740 and the SVB Security Agreement was recorded with the USPTO on May 5, 2006 at Reel 3303, Frame 0589.
5. The Company, and not Grantor, owns and has always owned the Scheduled Trademarks.
6. Due to unknown reasons, Grantor listed on the Security Agreements, and granted security interests in, the Scheduled Trademarks despite the Scheduled Trademarks being owned by the Company.
7. Because the Scheduled Trademarks were and continue to be owned by the Company, the security interests with respect to the Scheduled Trademarks were granted and recorded in error, and such security interests are not and were never valid or in force and effect.

The undersigned, being hereby advised that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, declares that the facts set forth in this Affidavit are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.

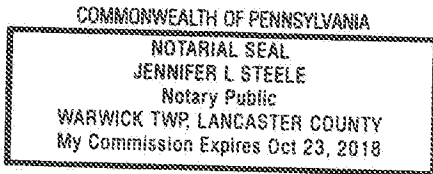


