## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is entered into as of November 14<sup>th</sup>, 2017 (the "Effective Date") by and between Mohinder Chhabra, an individual residing in Plantation, Florida ("Assignor") and Eisha Holdings Inc., a corporation organized under the laws of the State of Florida and having an address of 2900 West Sample Road, Pompano Beach, Florida 33073 ("Assignee").

WHEREAS, Assignor is the owner of the registered trademark, common law trademark, service mark, trade name, corporate name, commercial identity and trading style GLAM COSMETICS and including confusingly similar designations for use in connection with cosmetics, make-up, lip balm, lip gloss and glitter for cosmetic purposes, including U.S. Registration No. 5319742 (the "Trademark"); and

WHEREAS, Assignee wishes to acquire the entire right, title, and interest in the Trademark in perpetuity;

NOW, the parties agree as follows:

1. **Assignment.** Assignor does hereby irrevocably assign to Assignee all right, title, and interest (including, but not limited to, all registration rights with respect to the Trademark, all rights to prepare derivative marks, all goodwill and all other rights), in and to the Trademark. This Assignment includes all licenses of the Trademark, as well as any and all past, present and future causes of action for royalties, for infringement, or otherwise, arising out of or relating to the use or exploitation of the Trademark, and the right to receive any and all fees, royalties or other compensation due or to become due with respect to the Trademark.
2. **Consideration.** In consideration for the assignment set forth in Section 1, Assignor shall pay Assignee the amount of US\$10.00 payable on the Effective Date.
3. **Representations and Warranties.** Assignor represents and warrants to Assignee:
  - (a) Assignor has the right, power and authority to enter into this Agreement;
  - (b) Assignor is the exclusive owner of all right, title and interest, including all intellectual property rights, in the Trademark;
  - (c) The Trademark is free of any liens, security interests, encumbrances or licenses;
  - (d) To Assignor's knowledge, the Trademark does not infringe the rights of any person or entity;
  - (e) There are no claims, pending or threatened, with respect to Assignor's rights in the Trademark;

- (f) This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and
- (g) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

4. Entire Agreement. This Agreement, contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof. There are no amendments, exhibits, or additional terms other than Exhibit A – Copy of Certificate of Registration for GLAM COSMETICS, U.S. Registration No. 5319742.

5. Amendment. This Agreement may be amended only by a written agreement signed by both parties which explicitly refers to this agreement.

6. Severability. If any term, provision, covenant or condition of this Agreement, or the application thereof to any person, place or circumstance, shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Agreement and such term, provision, covenant or condition as applied to other persons, places and circumstances shall remain in full force and effect, except as mandated by the ruling.

7. Agreement to Perform Necessary Acts. Assignee agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.


8. Governing Law; Jurisdiction. This Agreement shall be construed in accordance with the laws of the State of Florida and all disputes shall be brought before the courts in Broward County, Florida. The parties waive objection to the jurisdiction of the courts of Broward County, Florida for such disputes including *forum non conveniens*.


