**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

- (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and
- (c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by Company against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.

The recording officer in the U.S. Patent and Trademark Office is hereby authorized to cancel the security agreement of record for the Trademark Collateral.


This release shall be binding upon Agent's legal representatives, assigns and successors.


