THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment"), dated as of August 1, 2017 (the "Effective Date"), is made by and between 3ES Innovation Inc., an Alberta corporation with offices located at 800, 250 2 St. SW, Calgary, Alberta, Canada T2P 0C1 ("3ESI") and Energy Navigator Inc., an Alberta corporation with offices located at #400 - 227, 11th Ave. S.W. Calgary, Alberta, Canada T2R 1R9 ("Assignor").

WHEREAS, Assignor is the owner of the trademarks and trademark registrations described on Schedule 1 hereto (the "Trademarks"); and

WHEREAS, pursuant to the terms of that certain General Conveyance and Assumption Agreement, by and between 3ESI and, dated as of August 1, 2017 (the "Conveyance Agreement"), Assignor has agreed to assign to 3ESI all of Assignor's right, title, and interest in and to the Trademarks (and the portion of the business of Assignor to which the Trademarks pertain), together with the goodwill associated therewith.

NOW THEREFORE, for the consideration set forth in the Conveyance Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. In connection with the transfer of the portion of the business to which the Trademarks pertain, Assignor hereby sells, transfers, conveys, assigns, and sets over unto 3ESI, and its successors and assigns, Assignor's entire right, title and interest in and to the Trademarks, including, without limitation, all registrations and applications therefor and the right to apply for and register the Trademarks, in the United States of America and all foreign countries, together with the goodwill of Assignor's business in which the Trademarks are used and symbolized by the Trademarks, all common law and statutory rights related thereto, all rights of renewal and extension, and the right to sue and recover for damages and profits for past infringements thereof.

2. This Trademark Assignment will be governed by and construed in accordance with the laws of the Province of Alberta without reference to such province's principles of conflicts of law.

3. This Trademark Assignment will inure to the benefit of and be binding upon 3ESI and Assignor and their respective successors and assigns. This Trademark Assignment may be executed in one or more counterparts, all of which will be considered one and the same agreement and will become effective when one or more counterparts have been signed by each of the parties and delivered to the other party, it being understood that all parties need not sign the same counterpart. Any such signature page will be effective as a counterpart signature page hereto without regard to page, document or version numbers or other identifying information thereon, which are for convenience of reference only. This Trademark Assignment may be executed by facsimile or .PDF signature, and a facsimile or .PDF signature will constitute an original signature for all purposes.
