TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 17, 2017, by U.S. BANK NATIONAL ASSOCIATION, as administrative agent (in such capacity, "Administrative Agent") for the Secured Creditors (as defined in the Trademark Security Agreement referenced below), in favor of BC TECHNICAL, INC., a Utah corporation, C & G TECHNOLOGIES, INC., a Kentucky corporation, GENESIS OPCO, LLC, an Illinois limited liability company (collectively, the "Companies" and each, individually, a "Company").

WITNESSETH:

WHEREAS, Companies and Administrative Agent are parties to that certain Trademark Security Agreement dated as of July 31, 2013 (the "Trademark Security Agreement"; capitalized terms used but not defined herein shall have the meanings given such terms in or by reference in the Trademark Security Agreement), pursuant to which Companies granted a security interest to Administrative Agent, for the benefit the Secured Creditors, in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 2, 2013, at Reel 5083, Frame 0796; and

WHEREAS, Companies have requested that Administrative Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Companies.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Companies' right, title and interest in and to the Trademark Collateral, including, without limitation, the following:

(i) each Trademark of Companies, including, without limitation, those listed on Schedule 1 annexed hereto, together with any reissues, continuation or extension thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including, without limitation, any claim by any Company against third parties for past, present or future (A) infringement or dilution of any Trademark or (B) injury to the goodwill associated with any Trademark.

2. Administrative Agent hereby releases, reassigns, grants and conveys to Companies, without any representation, recourse or undertaking by Administrative Agent or any other Secured Creditor, any and all of Administrative Agent's right, title and interest in and to the Trademark Collateral.


