TRADEMARK AND DOMAIN NAME ASSIGNMENT

THIS TRADEMARK AND DOMAIN NAME ASSIGNMENT (this "Assignment") is made and entered into as of December 17, 2015 ("Effective Date") by and between SBD Holdings Group Corp., a Delaware corporation, located at 24311 Walden Center Dr., Suite 200, Bonita Springs, FL 34134 ("Assignor"), and Nutrisystem SBD, LLC, a Delaware limited liability company, located at Fort Washington Executive Center, 600 Office Center Drive, Fort Washington, PA 19034 ("Assignee"). Capitalized terms used but not defined herein shall have the meanings set forth in the Purchase Agreement (as defined below).

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of December 17, 2015, by and among Assignor and Assignee (the "Purchase Agreement"), Assignor has sold to Assignee the Purchased Assets;

WHEREAS, the Purchased Assets include, among other assets, the Trademarks (as defined in Section 1 below) and Domains (as defined in Section 2 below), together with any and all goodwill associated with any of the foregoing (the "Intellectual Property");

WHEREAS, Assignor has agreed to assign and transfer to Assignee, and Assignee has agreed to accept and assume from Assignor, all of Assignor's right, title and interest in and to the Intellectual Property, such that Assignee will be the owner of the Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows, effective immediately:

1. Assignor hereby irrevocably sells, conveys, transfers and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Assignor's right, title and interest in and to all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, collective membership marks, logos, other similar designations of source, all registrations and recordings thereof, and all applications filed in connection therewith (the "Trademarks") included in the Purchased Assets, including the trademark registrations and applications set forth on Schedule A attached hereto, together with the goodwill that is symbolized by such Trademarks, and further including any and all (i) renewal rights in respect of such Trademarks, (ii) rights to obtain registrations of such Trademarks in the United States and throughout the world, (iii) all income, royalties and proceeds arising out of any of the foregoing (other than the right to receive payments contemplated by Section 1.2(d) of the Purchase Agreement) and (iv) the unrestricted right to seek enforcement of any and all intellectual property rights granted herein and under the law to the fullest extent, including the right to sue for and recover any and all damages and profits, the right to file for injunctive relief and the right to seek any and all other remedies for past, present and future infringements, dilutions, or violations thereof against third parties, all in Assignee's sole name.

2. Assignor hereby irrevocably sells, conveys, transfers and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Assignor's right, title and interest in and to all the domain names (the "Domains") listed on Schedule B hereto, including statutory and contractual

rights, all registrations that have been or may be granted thereon, and all applications for registrations thereof.

3. Assignor shall cooperate with Assignee in any action Assignee reasonably requests that Assignor takes in order to effectuate, carry out, or fulfill the parties' intent and/or Assignor's obligations hereunder, including the execution of any instruments and papers that are necessary or desirable, in Assignee's reasonable discretion, to consolidate, confirm, vest and/or record Assignee's full and complete ownership of the Intellectual Property with, for example, the United States Patent and Trademark Office (or any corresponding foreign entity or agency); provided, however, that it being understood that Assignor shall not be required to (i) commence any litigation in connection with this Section 3; or (ii) expend money in connection with this Section 3. With respect to the Domains, such actions may include assisting Assignee in changing the technical and administrative contact information for the Domains with the applicable domain name registrars to such information of Assignee's choice, releasing any "lock" placed on the Domains, obtaining the authorization code and providing that code to Assignee, and/or confirming the requested transfer upon receipt of a request to do so from the registrar used by Assignee for the transfer of the Domains.

4. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail. For the avoidance of doubt, the Trademarks and Domains shall not include any Excluded Intellectual Property.

5. This Assignment may be executed in separate counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

6. This Assignment, its construction, and the remedies for its enforcement or breach are to be applied pursuant to, and in accordance with, the laws of the State of Delaware, without regard to the principles of conflicts of law thereof.
