This letter shall confirm the parties' mutual understanding with respect to the transaction described herein ("Assignment") between The Treadstone Group, Inc. ("Buyer") and Jingjing Ye and Zusen Du (collectively, the "Seller").

 - c. Due Diligence Review. Promptly following the execution of this Assignment, Seller shall allow Buyer to obtain the Property with no extra charges or any past bills related thereto. Any information obtained by the parties as a result of the Assignment shall be held in confidence. The parties shall cooperate, and take all reasonable actions necessary in order to carry out the intent and purposes of this Assignment.
