## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of October 27, 2017 by **BANK OF AMERICA, N.A.**, a national banking association (the "*Bank*"), in favor of **ARCTURUS MARINE SYSTEMS**, a California corporation (the "*Grantor*").

**WHEREAS**, the Grantor executed and delivered a Memorandum and Notice of Security Interest in Intellectual Property dated as of July 13, 2016 (the "*Agreement*"), granting the Bank a security interest in and lien on certain trademarks described and defined therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 8, 2016, at Reel 5848, Frame 0720;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO by the Grantor.
