**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of October 27, 2017 by **BANK OF AMERICA, N.A.**, a national banking association (the "*Bank*"), in favor of **NAV-X CORPORATION**, a Florida corporation (the "*Grantor*").

**WHEREAS**, the Grantor executed and delivered a Memorandum and Notice of Security Interest in Intellectual Property dated as of July 13, 2016 (the "*Agreement*"), granting the Bank a security interest in and lien on certain trademarks described and defined therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 8, 2016, at Reel 5849, Frame 0620;

**WHEREAS**, the Grantor has requested that the Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the trademarks as fully described on the attached Schedule I (collectively, the "*Trademarks*") as herein provided; and


**WHEREAS**, the Grantor has requested that the Bank provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO by the Grantor.


