**OWNERS'S DECLARATION UNDER 37 C.F.R. §2.20, IN SUPPORT OF
REQUEST TO CORRECT CLERICAL ERROR**

Mr. Antonio Croce hereby declares as follows:

1. I am employed at GIORGIO ARMANI S.P.A., MILAN, SWISS BRANCH MENDRISIO ("Giorgio Armani") where I hold the title of Intellectual Property Manager.
2. I am fully familiar with the facts stated herein based on my review of all relevant documents and records. I have therefore acquired knowledge of the corporate events related to the ownership of the mark.
3. I am properly authorized to sign on behalf of Giorgio Armani.
4. On March 17, 2010, certain merger documents were recorded with the US PTO Assignment Division under Reel/Frame: 4168/0391, showing that the initial owner of the above-identified registration, Swiss company GA MODEFINE S.A., merged into Italian Company Giorgio Armani S.p.A., to operate under the full name of Giorgio Armani S.P.A., Milan, Swiss Branch Mendrisio.

5. As it is apparent from the documents recorded under Reel/Frame: 4168/0391, Giorgio Armani S.P.A., Milan, Swiss Branch Mendrisio is located in Switzerland but it is registered in Italy with the Milan Register of Companies and acts as a branch office of Giorgio Armani S.p.A.

6. Therefore, the assignment correctly identifies Giorgio Armani S.P.A., Milan, Swiss Branch Mendrisio, as the owner's name by merger, with an address of record at Via Penate 4, Ch-6850 Mendrisio, Switzerland.

7. However, due to a clerical error, the assignment cover sheet erroneously identifies Giorgio Armani S.P.A., Milan, Swiss Branch Mendrisio, as a Swiss join stock company.

8. The correct country of incorporation of Giorgio Armani S.P.A., Milan, Swiss Branch Mendrisio is Italy.

9. To the best of my knowledge, there are no companies named Giorgio Armani S.P.A., Milan, Swiss Branch Mendrisio, organized as a Swiss corporation, and existing today or at the time when the merger documents were executed or filed.

10. To the best of my knowledge, the typo regarding Applicant's country of incorporation is the result of a minor clerical error, and was made unintentionally.

11. In view of the foregoing, Giorgio Armani wishes to correct the mistake in the country of incorporation from Switzerland to Italy.

12. The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or document or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
